Decisions taken by Clerk out of meeting

Gate

Following reports of noisy behaviour and broken bottles outside the Matfield convenience the Clerk has purchased a chain and padlock to secure the gate into the small area of land behind it. Messrs C A Forward and Co have been asked to repair the gate together with the broken posts around the green and pavilion.

Humphreys

Advice has been received from a neighbour that trade waste is being burnt in gardens, that trees are disappearing presumably because of wood burning stoves and that with wheelie bins being left out on the pavement and often overflowing, rats have been seen. TCHG have been advised.

Other Meetings Attended

Matfield Shop

Cllr Mrs Cornford reported on a brief meeting with the proprietors of the new Matfield shop and preparations were nearly complete for the launch on Thursday the 8th. Concern had been expressed that no Post Office sign was in evidence but it would appear that this was only erected once the business was operating. Cllr Mrs Cornford was writing to Mr P Wilkinson to chase this. The Courier, the BBC and Radio Kent had been invited.

Matters Arising

Standing Orders

The NALC standing orders have been received and as agreed previously need reviewing in comparison to our own. Cllr Woodley agreed to review the SO and confer with Cllr McEwen before making their recommendations.

Matfield Green

Quotes have been received from J P Miles and Co and Greenacres Landscape Services to repair the verge at the rear of the green. There is a wide disparity with the quotes based on different types of approach to the problem. The Clerk was asked to investigate further and report.

Electricity

We currently use EDF who charge 10.69p/kWh but have decided to add a standing charge of £78.84/qtr. EON quote 10.5p/kWh with no standing charges at present. Our last bill from EDF included £65.21p of energy charges, which has been paid and £78.84p of standing charges, which has not. It was agreed to transfer our business to EON providing the Clerk found nothing in terms of short-term problems with the new agreement.

Jefferson

The Clerk was asked to enquire if the newly built fishing lodge at the junction of Foxhole Lane and Romford Road is within our Parish and to find out if planning permission has been granted. From a conversation with TWBC the location is within the Parish of Pembury and that the owner has been invited to submit a retrospective planning application.

Correspondence

War Memorial

A request and invoice from Messrs Burlite for a further stage payment of £2838.90 plus VAT. The original grant of £3077.50 from 2006 has been confirmed as still available.

A meeting on 22nd March between Mr T Maw, Alan Legg of TWBC and Messrs Burlite is reported as having gone well. Burlite attended with 3 men, 2 vans and some scaffolding to take some final dimensions. The promised installation of the cross is 19th April. The Clerk has had a conversation with Mr Newton of Burlite and the balance is principally the cost of scaffolding and fitting the cross. He also advises that the column of the memorial is loose in its juggle (socket) and he will stabilise this by drilling an oblique hole through it and inserting a stainless steel pin. Thereafter the cross will be cut off in pieces, the method of fixing ascertained and the new cross machined to suit. He does advise that the new cross will look very much lighter in colour than the existing but with time it will weather to match. The PC discussed this and agreed that we would pay this instalment to Messrs Burlite on the day that they remove the cross from the column in preparation for the new installation and invite them to provide a sign whilst work was in progress advising they were the responsible contractors.

Residents

A letter has been received from a resident in Colts Hill welcoming measures to improve safety and suggesting various signage and road markings. The Clerk was asked to reply. A letter has been received from a resident who is in the process of appealing against a decision to refuse their retrospective application for a commercial operation in Palmers Green Lane advising that they have complained to Alex King of bias from TWBC and requesting a copy of the Parish Charter, which has been supplied.
